

Course Overview

Course Title: Diploma in Pharmacy (D. Pharma).

Type of Course: A Two years Diploma course

Pattern: Yearly

Award of the Degree: Diploma will be awarded for those passing in both the years as per rules and regulations.

Eligibility For Admission In D.Pharma:

No. Candidate shall be admitted to Diploma in Pharmacy Pt. I unless **he/she had passed any of the following examinations in all the optional subjects and compulsory subjects (Physics, Chemistry, Biology and /or Mathematics including English as one of the Compulsory subjects):**

a) Intermediate examination in Science; The First Year of the three year degree course in Science; 10+2 Examination(Academic stream) in Science;

b) Pre-degree examination; any other qualification approved by the Pharmacy Council of India as equivalent to any of the above exam.

Admission of candidates to the Diploma in Pharmacy Part -I shall be made in order of merit on the basis of 'Pre-Pharmacy Test' conducted in accordance with the scheme of Examinations and syllabus laid-down by the Board.

General Institution Rules

- 1. All Students Must have to follow Rules and Regulation as Per Pharmacy Council Of India & Board Of Technical Education , Uttar Pradesh , which are updated from Time to Time .**
- All Students have to be punctual and always be in proper uniform as prescribed by the Institution Authorities.
- All Students have to maintain peace and harmony in the Campus, Class, Laboratory, Library & Hostel .
- Mobiles are not allowed in the College Premises.

- All kinds of fee should be submitted within the Prescribed time and delay may lead to the imposition of the fine .
- All Student Must appear in the class test / Internal Examination Otherwise strict action may be taken by the authority.
- Student may represent any matter to authority (M.D/ Administration / Principal/ Vice Principal) through H.O.D/ Co-Coordinator , they should not take law or decision into their Own Hands.
- Students are required to follow all the rules and regulation of the Institution.

Leave Rules

- The Students must be present in 80 % of the Syllabus and 100 % of The Practical .
- The Students are not allowed to proceed on leave except in very special circumstances.
- In case of any emergency and casually the students Must inform the Faculty/Administration and will Request for the Grant of leave .
- The Students who are absent without the Grant of Leave must have a very Genuine Condition otherwise will have to face Strict action from Administration .

Library Rules

- The library remains Open from 10:00 am to 4 :00 pm .
- Each Student is Entitled to Get One Books issued at any given time . The Student must return the book within 7 days time otherwise late fees of Rs 10- per day will be charged form the students.
- Periodicals , Publication and newspapers must not be taken away under any circumstances.
- Students are not allowed to write on the Library Book or Tear pages from the Library Book .
